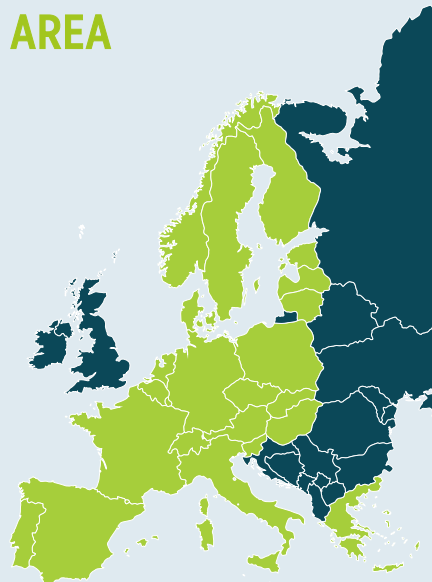

For medical claims of more than € 500, you need to send us by postal mail to ACS Medical Service - Attention of Medical Advisor 153, rue de l'Université 75007 Paris – France, the following documents: ACS medical claim form (downloadable on our site) accompanied with the original paid invoices, copies of the prescriptions, a complete medical report and a copy of your passport.

## WHY SHOULD I SUBSCRIBE TO EUROPAX ?

When you travel to Europe, you may need a visa to enter the Schengen Area. The Schengen visa requires a private travel insurance which covers your medical fees up to EUR 30 000 as well as your repatriation to your home country and your personal liability.

## WHO CAN SUBSCRIBE?

International travellers under 70 years old travelling, outside their home country, throughout Europe's Schengen area for 90 days or less.

- Your contract can be subscribed for the length of your choice from 1 to 90 days.
